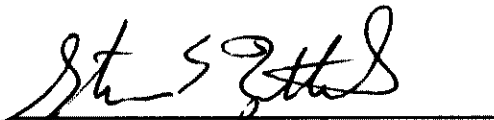

Upon resolution of the board of directors and the unanimous vote of the stockholders these Articles of Amendment are submitted.

1. The corporation is Orion Expeditions (Idaho), Inc.
2. The amendment adopted by the corporation is to change the corporate name from Orion Expeditions (Idaho), Inc. to American Adrenaline Company.
3. The amendment was adopted by the shareholders at a special meeting for that purpose held on January 12, 1993, at Challis, Idaho.
4. The number of shares outstanding at the time of the special meeting was 30,000 shares. The number of shares entitled to vote at the special meeting was 30,000 shares. All shares are of one class: Common.

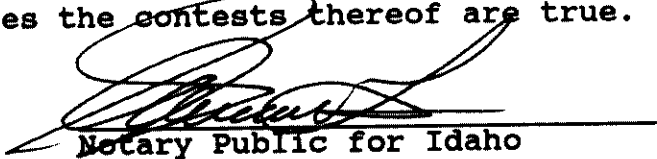
