# ARTICLES OF ORGANIZATION OF

## THE CUSTOM FIT, LIMITED LIABILITY COMPANY

The undersigned, being the Members and Organizers of the Limited Liability Company hereby being formed under the Idaho Code Sections 53-601 to 53-672, do hereby adopt the following Articles Of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

THE CUSTOM FIT, Limited Liability Company

SECOND: The latest date on which the Limited Liability Company is to dissolve is June 1, 2025.

THIRD: The Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with the Idaho Code Sections 53-601 to 53-672, including all powers and purposes now and hereafter permitted by law to a limited liability company.

FOURTH: The street address of the initial registered office of the Limited Liability Company in Idaho is 152 North Beryl Avenue, Victor, ID 83455, and the name of the initial registered agent of the Limited Liability Company in Idaho at that address is Teri Pancoast.

FIFTH: The principal place of business of the Limited Liability Company is 152 North Beryl Avenue, Victor, ID 83455.

SIXTH: The Limited Liability Company is to be managed by a Managing Member. The name and address of the initial Managing Member is Teri Pancoast, having an address at 152 North Beryl Avenue, Victor, ID 83455

SEVENTH: The membership interests of the Members are evidenced by Certificates of Membership.

EIGHTH: The existing Members shall have the right to admit additional Members to the Limited Liability Company, by the unanimous vote or consent of the Managing Members, in accordance with the terms and conditions of the Operating Agreement of the Limited Liability Company.

NINTH: The remaining Members of the Limited Liability Company, by the affirmative vote or consent of Members holding 75 percent of the Members' Percentage Interests (other than the Member who caused the Withdrawal Event), may continue the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the

occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company.

TENTH: None of the Members of the Limited Liability Company are liable for payment of any debt, obligation or other liability of the Limited Liability Company.

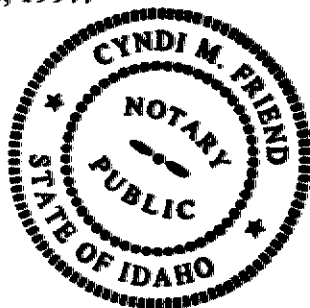


