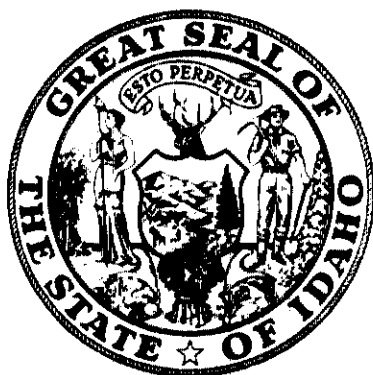

In accordance with Section 30-1-59 of the Idaho Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

ARTICLE SIX.

Restriction On The Alienation of Stock: The stock of the corporation may be subject to restriction on the alienation of stock pursuant to agreement if filed with the secretary of the corporation.
