KNOW ALL MEN BY THESE PRESENTS: That William S. Dixon, the undersigned, being a natural person of legal age and a citizen of the United States of America, in order to form a corporation for the purposes hereinafter stated, pursuant to the laws of the State of Idaho, does hereby certify as follows:

I.

Name

The name of the corporation shall be Soho, Inc.

II.

Registered Office

III.

Duration
