The undersigned David A. Cathey, Jr. and Joel M. Frendt being the President and Secretary of Micron Display Technology, Inc., respectively, hereby execute pursuant to Idaho Code 30-1-61 the following Articles of Amendment for Micron Display Technology, Inc., an Idaho Corporation:

A. The name of the corporation is Micron Display Technology, Inc.

B. Article IV of the corporation's Articles of Incorporation is amended to read in its entirety as follows:

"ARTICLE IV

The aggregate number of shares the corporation will have authority to issue is thirty million (30,000,000) shares of \$0.10 par value per share common stock."

C. The amendment herein was adopted by the shareholders on the 26th day of July, 1996.

D. There are 823,399 shares of the corporation's common stock outstanding and entitled to vote respecting an amendment to the corporation's Articles of Incorporation.

E. 820,003 shares voted for the amendment, 318 voted against the amendment and 3,078 shares did not vote.

F. The amendment herein does not provide for an exchange, reclassification or cancellation of issued shares.

G. The amendment herein does not effect a change in the amount of stated capital.
