

ARTICLES OF INCORPORATION

of the

"DOUGLAS MINING COMPANY,LIMITED.*

KNOW ALL MEN BY THESE PRESENTS: That we, F. P. Johnson, C. C. Titus H. J. Rossi, H. E. Howes, H. G. King, O. D. Jones, J. W. Tabor, J. L. Batterton, H. C. Adami, T. R. Roberts, and J. C. McDiarmid, a majority of whom are resident freeholders and bona fide residents of the State of Idaho, do hereby voluntarily associate ourselves together for the purpose of forming a corporation and becoming a body corporate under the laws of the State of Idaho, and we hereby declare and set forth:--

First,---That the name of this corporation is and shall be "Douglas Mining Company, Limited".

Second,---That this corporation is formed for the purpose of purchasing, selling, bonding, leasing, working, and operating mines and mining claims, water-rights, mill-sites and easements incident thereto, and such other real property as may be lawfully acquired by a corporation under the laws of the United States, and the State of Idaho.

Purchasing, renting, leasing and building mills, concentrators, and other works and machinery necessary for the purpose of milling, concentrating, and handling ores and the products thereof. Buying, selling, working, milling and concentrating ores; building and operating railroads and tramways necessary for the transaction of their business.

Third,---That the principal place of business of the said corporation shall be at the City of Wallace, County of Shoshone, State of Idaho.

Fourth,---That the term for which this corporation shall exist shall be fifty years.

Fifth.--That the number of the directors of this corporation shall be seven, and the names and residences of the directors who are appointed for the first year, and to serve until the election and qualification of their successors, are as follows, to wit:
