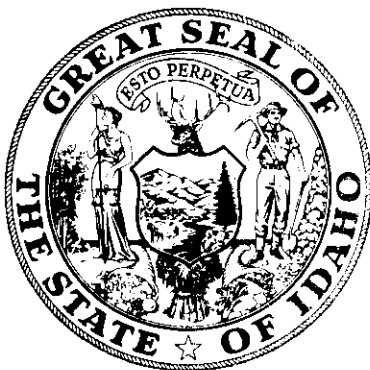

ARTICLES OF INCORPORATION

ARTICLE I

The name of this Organization shall be: The Big Creek Fire Department, *Inc.*

ARTICLE II

This Organization is a Non-Profit Corporation and existing under the laws of the State of Idaho.

This Organization shall be perpetual.

ARTICLE IX

Officers of this Organization shall be elected at the yearly meeting in October of each year. The elected Officers shall be President (Fire Chief); Vice-President (Chief Engineer and Mechanic) and Secretary-Treasurer.

Chairman of the Board of Directors shall be appointed by the President.

ARTICLE X

Articles of this Organization may be changed from time to time providing that two (2) Officers and one-half of its Directors be present in doing so.

ARTICLE XI

No member or members of this Organization shall sue or cause to be sued any other member or members when the member or members exercise due care or act in good faith as any prudent person or persons would in the line of duty.

No person or persons shall be denied membership if he or she are property owners because of race, color, creed or religion to this Organization.

Any person or persons that purchase or inherit property from any member of this Organization shall automatically become a member by paying up dues or assessments if any are due.

BY-LAWS OF THE BIG CREEK FIRE DEPARTMENT

ARTICLE VII

DISBANDMENT:

This Organization shall not be disbanded except by two (2) Officers and ^{majority} ~~one-half~~ of its members and a published or personally served notice shall be given of a meeting called for that purpose.

ARTICLE VIII

These By-Laws may be altered or amended by two (2) Officers and one-half of all members at any regular or special meeting of this Organization, provided such alterations or amendments has been proposed by two (2) Officers and one-half of its members and entered into the minutes by the Secretary-Treasurer and notice given to each member at least five (5) days prior to such meeting.

We the undersigned do hereby certify that the foregoing By-Laws were duly adopted at a meeting called on the 3rd day of October, 1981 and that no alterations or amendments have been brought up before the Organization since that date.
