THAT WE, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a Corporation under the Laws of the State of Idaho;

**AND WE HEREBY CERTIFY:**

First. That the name of said Corporation is **Teton Valley Percheron Horse Company, Limited,**

Second. That the purposes for which it is formed are **Owning and controlling Stallions and Brood Mares and breeding of horses, and things incidental thereto,**

Third. That the place where its principal business is to be transacted shall be **Driggs, Fremont County, Idaho.**

Fourth. That the term for which it is to exist is **Fifty** years from and after the date of its incorporation.
