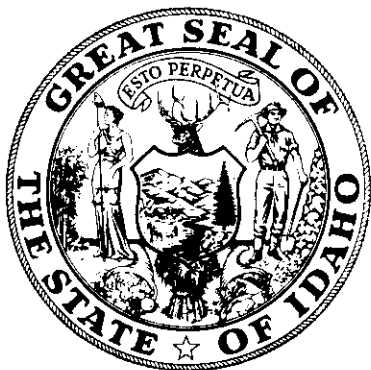

ARTICLES OF INCORPORATION

OF

CANIDA, INC.

The undersigned, acting as the Incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

I.

The name of the corporation is CANIDA, INC.

II.

The period of its duration is perpetual.

III.

The purpose or purposes for which the corporation is organized and the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

IV.

The aggregate number of shares which the corporation shall have authority to issue is 5,000, all of which shall be common stock with a par value of \$1.00 per share.

V.
