ARTICLES OF INCORPORATION

OF

FIRST FREE WILL BAPTIST CHURCH
OF RUPERT, IDAHO, INCORPORATED

The undersigned, being legal residents of the State of Idaho, and of full legal age, do hereby adopt the following articles as the Articles of Incorporation of the First Free Will Baptist Church of Rupert, Idaho, pursuant to the Idaho Nonprofit corporation Act.

FIRST: The name of the corporation is First Free Will Baptist Church of Rupert, Idaho, Incorporated.

SECOND: The period of duration of the corporation is perpetual.

THIRD: The purposes of the corporation are as follows:
To preach the Gospel of the Lord Jesus Christ, by all of the known means: Such as, the pulpit, personal work, Bible Schools, Radio and printed page. To labor for the promotion of education of the Holy Scriptures, the support of missions, the success of Sunday Schools, and fellowship and perfecting of the Saints and Salvation of the Lord.

In addition to the foregoing list of purposes which shall not be deemed to be all-inclusive, the corporation shall be formed for the purpose of acquiring by purchase, lease or

donation such real and personal property as may be necessary to carry out the religious and charitable purposes of the corporation.

FOURTH: The members of the church shall not be legally liable for debts of the corporation, except to the extent they may have personally guaranteed debts of the corporation, and members shall not be legally liable for assessments made against them on behalf of the corporation, whether to further corporate purposes or for payment of indebtedness or liabilities of the corporation.

FIFTH: The address of the initial registered office of the corporation is c/o Faye Buck, Route 4, Box 342, Rupert, Idaho 83350. The name of the initial registered agent at such address is Faye Buck. The church and meeting facilities are located at 206 East 6th Street, Rupert, Idaho.

SIXTH: The management of the corporation is vested in a board of three trustees elected by the membership of the church, pursuant to the by-laws. The trustees shall not sell, mortgage, or otherwise encumber the property without the consent of two-thirds of the members given at a meeting called for the purpose after proper notice as provided in the by-laws.

SEVENTH: Membership in the church corporation shall be

governed by the by-laws.

EIGHTH: The corporation shall adopt by-laws governing the management of the corporation at a meeting of the general membership called for such purpose within 60 days after filing of these articles of incorporation. Said by-laws shall be adopted by a majority of persons attending who are acknowledged by the incorporators to qualify for membership in the corporation. Thereafter, the by-laws may be amended by the vote of two-thirds of the members in attendance at a meeting called for such purpose.

NINTH: The number of trustees constituting the initial board of trustees shall be three. The names and addresses of the persons who are to serve as trustees until the first general meeting of the membership following the filing of these articles of incorporation, or until their successors shall qualify are:

TENTH: It is the intent of the incorporators that this corporation be formed for the tax exempt, non-profit religious and charitable purposes set forth above. In the event of the

dissolution of this corporation, its assets shall be distributed to a charitable non-profit corporation determined by the board of trustees to have the same or similar purposes. No assets shall be distributed to the members upon dissolution.
