THAT WE, The undersigned, being natural persons of full age and citizens of the United States of America, have this day voluntarily associated ourselves together for the objective of forming a corporation under and pursuant to the provisions of the GENERAL CORPORATION LAWS Of the State of Idaho and acts amending and supplementing said laws, do hereby certify as follows:

ARTICLE I

The name of the Corporation is "FAR-LEE AG SERVICE, INC."

ARTICLE II

The purposes and objects for which the Corporation is formed are:

- (a) To conduct and carry on the general business of buying, selling and applying all the various chemicals, fertilizers and seed.
- (b) To conduct and operate the general business of buying, selling and servicing all types of materials, goods, wares and merchandise.
- (c) To own and operate all forms of transportation conveyances including, but not limited to, transportation of passengers for fare by airplane as well as transporting freight and application of chemicals, fertilizers and seed by air.
- (d) To conduct business in the state of Idaho, other states, District of Columbia, territories and colonies of the United States, and in foreign countries, and to have one or more offices and places of business out of this state, and to acquire, receive, hold, purchase, lease, mortgage, dispose of and/or convey real and personal property situate out of this state.
- (e) To purchase and re-issue the shares of its capital stock according to law, and when such stock is owned by the corporation such stock will not be considered voting stock directly or indirectly.

(f) The power and capacity to act possessed by a natural person which acts are necessary or proper to accomplish the corporate purposes and which are not repugnant to law including, but not limited to all the powers and authority now or hereafter conferred by the laws of the state of Idaho upon corporations formed thereunder.

It is hereby expressly provided that the enumeration of the foregoing purposes and objects of the said Corporation shall not be construed to limit or restrict the general powers of the Corporation.

ARTICLE III

The existence of this Corporation shall be perpetual.

ARTICLE IV

The location of the registered office in this state shall be located in Homedale, County of Owyhee, Idaho and the Post Office address shall be "%The Homedale Airport, Homedale, Idaho."

ARTICLE V

The total authorized number of par value shares is twenty five hundred (2500) and their aggregate par value is Twenty Five Thousand (\$25,000.00) Dollars. Par value per share is Ten (\$10.00) Dollars. The Corporation has not authorized the issuance of any no par value shares of stock.

ARTICLE VI

There shall be only one class of stock, and it shall be designated as common stock. The shares of stock shall not be issued until payment in full has been received, and such stock shall be nonassessable stock and the face of the certificate shall state on its face that it is nonassessable stock and the shareholders shall have no liability for corporate obligations. Each share of stock shall have the voting rights as now or hereafter granted by the laws of the state of Idaho relating to corporations.
