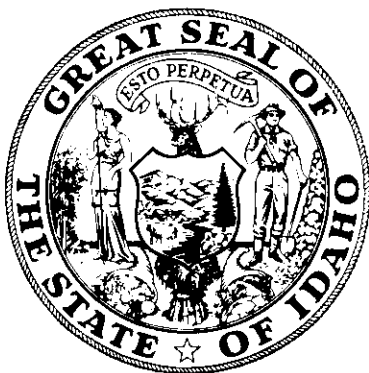

ARTICLES OF INCORPORATION
OF
CHERRY'S RESTAURANT & SALOON, INC.

The undersigned, acting as incorporators under the provisions of the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

1. NAME. The name of the corporation is:
Cherrys Restaurant & Saloon, Inc.
2. DURATION. The period of its duration is perpetual.
3. PURPOSES. The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
4. STOCK. The corporation shall have the authority to issue 150,000 shares of capital stock, all of one (1) class, ONE & 00/100 DOLLAR (\$1.00) par value.
5. ADDRESS. The address of the initial registered office of the corporation is:

first annual meeting of shareholders or until their successors have been elected and qualified.
