ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That I, the undersigned, being a citizen of the United States and a person of full legal age, do hereby form a domestic corporation under and pursuant to the laws of the State of Idaho, and do hereby certify:

ARTICLE I

The name of this Corporation shall be WHITE STAG BUILDERS, INC.

ARTICLE II

This Corporation is formed for the purpose of transacting any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho including, but not limited to, the following:

To build and construct, and manage the building and construction of, residential, commercial and industrial buildings and structures;

To purchase or otherwise acquire, own, hold, develop, lease, sell, exchange, assign, transfer, mortgage or otherwise dispose of real property, and to invest, trade and deal in and with real property, and any and all interests therein whether located within or without the State of Idaho.

To purchase or otherwise acquire, own, hold, lease, exchange, assign, transfer, mortgage, pledge or otherwise dispose of, and to invest trade in and secretary of state and deal in and with personal property of every class and deal in an every class and deal in an

To enter into any kind of an agreement or contract, cooperative or profit sharing plan, with its officers or employees that the Corporation may deem advantageous and expedient, or otherwise to reward or pay such persons for their services as the directors may deem fit.

To borrow money, to issue bonds, debentures, notes and any other obligations of this Corporation, and to mortgage, pledge, hypothecate, and/or convey in trust, any or all of its property to secure the payment thereof.

To discount and negotiate promissory notes, drafts, bills of exchange, and other evidences of debt; to enter into, make, perform, and carry out contracts of every kind and for any lawful purposes, without limit as to amount, with any person, firm, association, corporation, municipality, state or government, or any subdivision, district or department thereof.

To do any and such other acts, things, business or businesses in any manner connected with or necessary, incidental, convenient or auxiliary to any of the objects hereinbefore enumerated, or calculated, directly or indirectly, to promote the interest of the Corporation; and in carrying on its purposes, or for the purpose of attaining or furthering any of its business, to do any and all acts and things, and to exercise any and all other powers which a co-partner or natural person could do or exercise, and which now or hereafter may be authorized by the laws of the State of Idaho or any other state of the United States of America or in any part of the world.

The several clauses contained in this statement of purposes shall be construed as both purposes and powers, and the statements contained in such clauses shall in nowise be limited or restricted by reference to, or inference from, the terms of any other clause, but shall be regarded as independent purposes and powers; and no recitation, expression or

declaration of specific or special powers or purposes herein enumerated shall be deemed to be exclusive, but it is hereby expressly declared that all other lawful powers not inconsistent herewith are hereby included.

ARTICLE III

The period of existence and duration of the life of this Corporation shall be PERPETUAL.

ARTICLE IV

The location and post office address of the initial registered office of the Corporation in the State of Idaho shall be: 401 Lake Lowell Ave., Nampa, Idaho 83686

and which place shall be the principal office for the transaction of business for the Corporation. The initial registered agent of the Corporation at such address shall be: WILLIAM MICHAEL MORRISS.

ARTICLE V

This Corporation is authorized to issue one class of shares of capital stock to be designated as common stock, with each share of stock having the same powers and voting rights as every other share. The total number of the shares of said common stock which this Corporation shall be authorized to issue is 1000. The stock shall be without par value.
