

ARTICLES OF INCORPORATION
OF

The undersigned persons, acting as the incorporators of a corporation organized under and pursuant to the Idaho Business Corporation Act, Chapter 1, Title 30 of the Idaho Code, adopts the following Articles of Incorporation:

Article I

Name. The Name of the Corporation is **Down Home HVAC, Incorporated.**

Article II.

Registered Office and Agent. The location of the Corporation is in the City of Idaho Falls, Bonneville County, Idaho. The address of the initial registered office is:

Article III.

Duration of Corporation. The duration of the corporation is perpetual.

Article IV.

Purposes of Corporation. The purpose or purposes for which the corporation is organized are:

To do anything that may lawfully be done by a corporation organized under the Idaho Business Corporation Act, as that act may be amended or supplemented from time to time.

The Corporation may conduct business and otherwise carry out its purposes and exercise its powers in any state, territory, district, or possession of the United States, or in any foreign

country, to the full extent permitted by the laws of the state, territory, district, or possession of the United States, or by the foreign country, and it may limit its purposes in any state, territory, district or possession of the United States, or foreign country.

Article V.

Authorization of Shares. The aggregate number of shares that the Corporation shall have authority to issue is 200 shares of common stock, which stock shall be without par value.

Directors.

1. **Number.** The Board of Directors of the Corporation shall consist of two members, who need not be residents of any particular state or shareholders of the Corporation. The number of directors may be increased or decreased from time to time by amendment of this Section of these Articles of Incorporation, but no decrease shall have the effect of shortening the term of any incumbent director.

2. **Initial Directors.** The initial directors of the Corporation who are to serve as the initial Board of Directors of the Corporation until the first annual meeting of shareholders and until their successors shall have been elected and qualified, are:


