## BOISE CHAMBER OF COMPERCE

The state of the state of

NAME ALL MEN BY THESE PRESENTS, That we, whose names are subscribed hereto, all of whom are bona fide residents and citizens of the State of Idahe, do hereby organise, constitute and associate ourselves, and such other person or persons as may hereafter become associated with us, into a body politic and corporate, under Chapter 195 of the Idaho Compiled Statutes, 1919, and the Laws of the State of Idaho relating to the organisation of corporations where pecuniary profit is not the object, and we hereby set forth, certify and declare:

# FIRST

That the name of this corporation is and shall be BOISE CHAMBER OF COMMERCE.

## SECOND

That the purposes and objects for which this corporation is formed are:

- (a) To advertise Roise and Idaho;
- (b) To secure new industries for Boise;
- (c) To foster present industries;
- (d) To promote the holding of conventions and exhibitions in Boise;
- (e) To premote transportation and further tourist travel through Roise;
- (f) To acquire real and personal property by nurchase, gift, bequest, or otherwise, and to hold and convey real and personal property and to hold title to real and personal property in truckt:

(g) To do any and all things usually and sustemarily done by organizations of like kind.

#### THIRD

That the place where the principal business of this corporation shall be transacted is the City of Boise, County of Ada, State of Idaho.

shall be limited to a term of fifty (50) years from the date of its incorporation.

#### <u> Pipte</u>

That the corporate powers of this corporation shall be vested in a board of nine directors.

#### SIXTH

That the said corporation is and shall be a membership corporation and corporations, associations and co-partnerships, as well as persons, may become members thereof.

There shall be two classes of membership, vis: two and Sustaining. Only members whose dues are paid are entitled to participate in the activities of the organization, provided, however, that each member in good standing, whether active or sustaining, shall be entitled to one vote in all meetings of the members. No voting by proxy shall be permitted at any meeting, but corporations, associations and co-partnerships may delegate some individual to represent them at such meetings and on the membership roll.
