ARTICLES OF INCORPORATION OF PROFESSIONAL HEALTH EDUCATIONAL SERVICES OF PROFESSIONAL HEALTH EDUCATIONAL SERVICES

The undersigned, in order to form a corporation pursuant to the Idaho Business Corporation Act, certify as follows:

ARTICLE I

Professional Health $M^{\mathcal{C}}$. The name of the corporation is Educational Services pereafter "Corporation").

ARTICLE II

The purposes for which this Corporation is organized are as follows:

- 1. To engage in <u>Educational Services</u>; and
- 2. To engage in any other lawful activity or business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The Corporation shall have perpetual existence.

ARTICLE IV
