ARTICLES OF INCORPORATION

ARTICLE I

The name of the corporation is the Mountain Home Community Chamber Orchestra, Incorporated.

ARTICLE II

The corporation is a nonprofit corporation.

ARTICLE III

Duration of the corporation shall be perpetual.

ARTICLE IV

The purposes for which the corporation is organized are:

1. Educational - To provide for continuing music education among students and adults of the performing arts, and to promote music education in the community.
2. Cultural - to enhance the community spirit and quality of life of the people of Idaho by musical performances at public and private ceremonies.
3. Financial - To provide a means by which any funds collected may be dedicated to operating expenses without consideration of profit, that any assets of the corporation are to become assets of the Parks and Recreation Department of Mountain Home of the State of Idaho. For instance, any sheet music purchased or musical equipment obtained to enhance the ability of the members of the corporation to play music shall become the property of the Parks and Recreation Department. Thus, any donations received from "Patrons of the Arts" are to be considered charitable donations to the Parks and Recreation Department.
4. Legal - To provide a means for any private, social, or governmental organization to recognize the Mountain Home Community Chamber Orchestra as a business entity organized under the provisions of the corporate laws of the State of Idaho.

ARTICLE V

The street address of the office of the corporation is 4453 A Sycamore, Mountain Home AFB, Elmore County, Idaho 83548. The registered agent at this address is Carlene George-McMillan.

ARTICLE VI

The members of the corporation shall be made up of current members of the orchestra. Management of the affairs of the corporation shall be vested in the members pursuant to section 30-314c, Idaho Code. The name and street address of the principal organizer is Carlene George-McMillan, 4453 A Sycamore, Mountain Home AFB, ID 83648.






