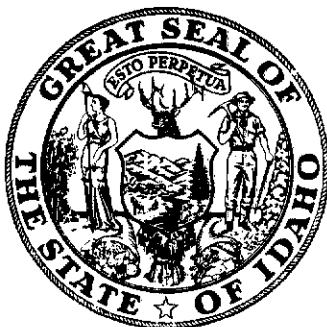

KNOW ALL MEN BY THESE PRESENTS, that I, the undersigned,¹ being a natural person of full age and a citizen of the United States of America, in order to form a professional corporation for the purposes hereinafter stated, pursuant to the laws of the State of Idaho, do hereby certify as follows:

FIRST

The name of this corporation shall be TIMOTHY A. WELEBIR, M.D., P.A.

SECOND

The location and post office address of the registered office of the corporation shall be 222 North 2nd, Boise, Idaho 83702.

THIRD

The name of the registered agent of the corporation is Timothy A. Welebir, M.D.

FOURTH

The period of existence and duration of the corporation shall be perpetual.

FIFTH

The purposes and objectives for which this corporation is formed are as follows:

A. To render professional medical services; to engage

in the practice of medicine, and to perform and engage in any other service ancillary to the practice of medicine.

B. To have, exercise and enjoy all of the powers now or hereafter granted to professional corporations organized under the laws of the State of Idaho, and particularly all of the powers and privileges granted to professional corporations by Chapter 13 of Title 30 of the Idaho Code, and any present and future amendments thereto, and to do any act or thing necessary or convenient for the transaction of the aforementioned business purposes and the carrying into effect of any and all of the aforesaid objectives and purposes.

SIXTH

The corporation shall have 1,000 shares of common stock with a par value of \$1.00 per share, for a total capitalization of \$1,000.00. Each share shall have the same rights, privileges and voting power and shall be nonassessable.

SEVENTH

The name and post office address of the incorporator is as follows:

EIGHTH

There shall be one director of the corporation, but the number of directors may be increased or decreased from time to time as provided by the By-Laws; provided, however, that the number of directors constituting the Board of Directors shall

never exceed the number of licensed physicians who are stockholders of the corporation. The name and post office address of the initial director is as follows:

The initial director shall serve until the first election of directors.

NINTH

The Board of Directors, by a majority vote, shall have the power to adopt By-Laws, and to repeal and amend By-Laws.

TENTH

The transfer of stock of the corporation shall be restricted and limited as provided by the Professional Service Corporation Act of the State of Idaho, the By-Laws of the corporation, and any other agreement entered into by and between the corporation and its stockholders; provided, further, however, that in no event shall any person be eligible to own stock in the corporation who is not a licensed physician under the laws of the State of Idaho, and any attempted transfer of stock to an ineligible person shall be void.
