

# ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF FREEMAN CORP.

Freeman Corp., a corporation organized under the Idaho Business Corporation Act, hereby adopts the following Articles of Amendment to the Articles of Incorporation for the Corporation, pursuant to Sections 30-1-8 and 30-1-59 of the Idaho Code.

#### ARTICLE I

The amendment adopted is as follows:

That the FIRST ARTICLE of the Articles of Incorporation of the Corporation is hereby amended to read as follows:
