



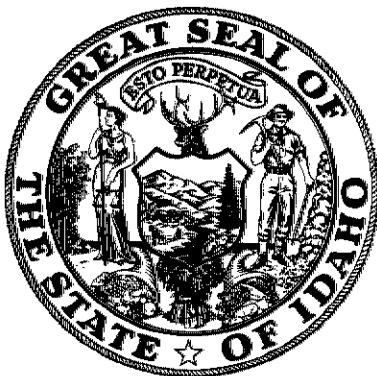
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

OF

COLORCRAFT, INCORPORATED

PAINTING & WALLCOVERING

The undersigned, acting as Incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Colorcraft, Incorporated.

SECOND: The period of its duration is perpetual. *PAINTING & WALLCOVERING*

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares of par value of \$1.00 each.

FIFTH: Provisions denying preemptive rights are: None.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are: None.
