Diapter 3 of the Idaho Code.

AFTICLE CNE

The name of the componation shall be (the) SouthEast Ideho Fraedom Find. Inc. Its principal office for the transaction of business shall be Focatello, loano.

ARTICLE INC

The computation shall elist perpetually, or until presidued according to law.

AFTICLE THEE

This componation shall not engage in any form of trade or commerce, nor directly or indirectly. Fin the price, or regulate the production, of any anticle of commerce or the produce of the soil, or the consumption of the same by the people, nor corry on any activity which will result in a remunerative profit to the componation or its members. Subject to the foregoing limitations, the business consuit, purpose and objects of this comporation are fraternal, patrictic, historical and educational; to preserve and strengthen commadeship among its members, to assist worthy commades; to persebuate the memory and history of our dead, and to assist their widows and orphans; to maintain true allegiance to the Government of the United States of America, and ficelity to its Constitution and laws; to feater true patrictism; to maintain and extend the institut one of American freedom; and to preserve and defend the United States from all her enemies, whosepower.

ARTITLE FOUR

The corporation will have members as defined in the Bi-Lave.

AFTICLE FIVE

In the event of dissolution of this componation, all of the assets shall be distributed to charateble non-profit institutions as defined by federal and state law and rules and regulations of the IRS and the Ideno State Tax Commission.
