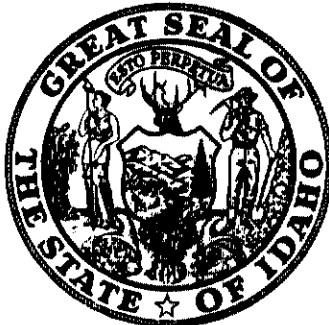
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION
OF

The undersigned, in order to form a corporation pursuant to Idaho Business Corporation Act, certify as follows:

ARTICLE I

The name of the corporation is Lankford Trucking Inc.
(hereafter "Corporation").
