The Undersigned natural person of the age of 18 years or more, acting as incorporator under the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

Article 1

Innova Development Corporation is the name of the corporation and its duration shall be perpetual.

Article 2

The corporation is being organized to engage in any and all lawful activities for which corporations may be organized under the Idaho business Corporation Act.

Article 3

The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares, no par value. Until such time as stock certificates are issued and shareholder records are established, Mr. Michael M. Mann, as the sole benefactor, who's personal funds established the Corporation, will be the sole shareholder of the company.

Article 4

The preemptive right to acquire additional or treasury shares of the corporation is hereby denied to the shareholders.

Article 5

The address of the initial registered office of this corporation is 3133 N. Treasure Drive, Boise, ID 83703, and the name of the initial registered agent at this address is Michael M. Mann.

Article 6

The number of directors of the corporation shall be fixed by the Bylaws of the corporation. The number of directors constituting the initial Board of Directors of the corporation is one director and the name and address of the person who is to serve as director until the first annual meeting of the shareholders or until his successor or other directors are elected and shall qualify are:

Article 7

The incorporator of this corporation is Michael M. Mann, whose address is 3133 N. Treasure Drive, Boise, ID 83703.

Article 8

The corporation may purchase, either directly or indirectly, shares of capital stock as evidence of indebtedness issued or created by the corporation, to the extent of unreserved or unrestricted capital or earned surplus available therefor. The directors may reissue such purchased shares or may provide that such shares not be reissued.

Article 9


The Board of Directors may, from time to time, declare and pay dividends on the corporation's outstanding shares in cash, property, or its own shares, to the extent legally available therefor.
