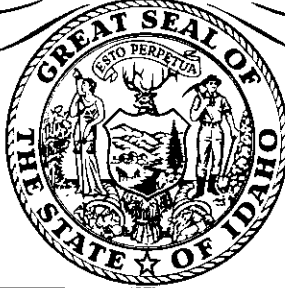

ARTICLE I.


The name of this corporation shall be "LEWIS-CLARK FAMILY PLANNING COUNCIL, INC."


ARTICLE II.
