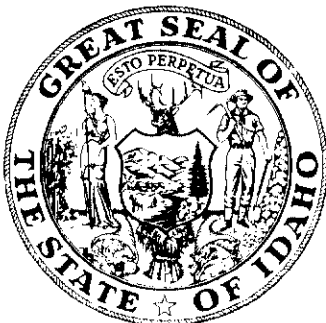

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, acting as  
 incorporators of a corporation under the Idaho Business Corporation Act, adopt the following  
 Articles of Incorporation for such corporation:

FIRST

The name of the corporation is WM. PHILLIPS' GRAZING ASSOCIATION, INC.

SECOND

The period of its duration is perpetual.

THIRD

The purpose or purposes for which the corporation is organized are as follows: To  
 buy, lease or otherwise acquire title to and possession of grazing and agricultural lands in the  
 State of Idaho and such other places as may be necessary to carry on the business and  
 accomplish the objectives of this corporation, the general operation of livestock, and all other  
 things incidental thereto necessary to conduct business, together with the transaction of all  
 other lawful business for which corporations may be incorporated under the Idaho Business  
 Corporation Act, Section 30-1-3.

FOURTH

The aggregate number of shares which the corporation shall have authority to issue  
 is FIVE HUNDRED shares of \$1.00 par value common stock.

FIFTH

Shareholders shall have full pre-emptive rights.
