**FIRST:** The name of this Corporation shall be LR3K, INC.

**SECOND:** This Corporation is formed for the purpose of transacting any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho including, but not limited to, operating a retail store for the sale of bedroom furniture and furnishings.

**THIRD:** The period of existence and duration of the life of this Corporation shall be PERPETUAL.

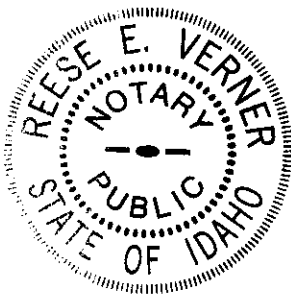
