ARTICLE ONE.

NAME

The name of this corporation is **HSK, INC.**

ARTICLE TWO.

DURATION

The Corporation shall have perpetual existence.

ARTICLE THREE.

The Corporation is organized for any lawful purpose including but not limited to:

LIMITED DIRECTOR LIABILITY




