

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned being persons of full age and being citizens of the United States, in order to form a corporation for the purposes hereinafter stated, pursuant to the Business Corporation Act of Idaho, do hereby certify that:

FIRST: The name of the corporation is SCOTT-TON, INC.

SECOND: The purposes for which said corporation is formed is for the purpose of conducting a trucking operation and for any other lawful purpose.

THIRD: The corporation is to have perpetual existence.

FOURTH: The corporation will do all banking transactions from Key Bank of Idaho, Fairview Branch, Boise, Idaho.

FIFTH: The location and address of the registered office of the corporation is 476 N. 12th St., Suite 100, Boise, Idaho, 83702, and the name of its initial registered agent is at such address and is Donald A. Lassaw.






