

ARTICLE VI

IN WITNESS WHEREOF, the undersigned organizing members of the above-named Company, have signed these Restated Articles of Organization this 17 day of December, 2001.

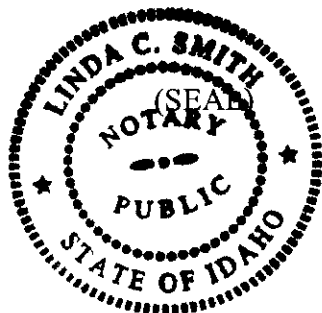
