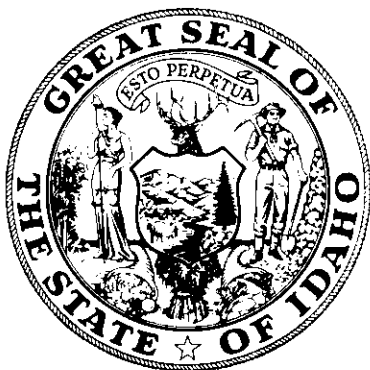

ARTICLES OF INCORPORATION  
OF  
IDAHO EQUIPMENT & SHEET METAL COMPANY

WE, THE UNDERSIGNED, acting as incorporators of a corporation hereinafter referred to as the "Corporation" under the provisions of the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is and shall be: IDAHO EQUIPMENT & SHEET METAL COMPANY.

ARTICLE II

The purposes of the corporation are as follows:

To buy, sell, manufacture, fabricate and deal in all kinds, forms and combinations of iron, steel, other minerals and metals, wood, plastics or other fabrics and materials, and in the products thereof, or in which any of said materials form a substantial part including, but not limited to heating, ventilating and air conditioning systems, equipment, supplies and parts thereof; to install the same in any machine, building or other structure, repair and service its own installations as well as those of others, and to transact a general manufacturing, fabricating, machinery, jobbing and supply business.

To conduct a general foundry and machine shop business and engage in the manufacture of all kinds of castings, machinery and parts thereof.

To buy and sell, export, import, lease, exchange and generally deal in real and personal property of every class and description.

To manufacture, purchase, or otherwise acquire, own, mortgage, pledge, sell, assign and transfer, or otherwise dispose of, to invest, trade, deal in and with goods, wares and merchandise.

To act as agents for the purchase, sale and handling of goods, wares and merchandise of any and all types and descriptions for the account of the corporation or as factor, agent, procurer, or otherwise for or on behalf of another.

To manufacture, repair, replace, produce or otherwise acquire, alter or repair merchandise of every class, nature and description, whether as principal or agent, whether now known or hereafter to be discovered or invented.

To deal in stocks, bonds, or other securities, investments, including the purchase and sale of the same, and in particular to purchase and sell, deal in or trade stocks issued by this corporation, and to acquire its own stock in such manner and upon such terms and conditions as the Board of Directors may determine to be in the best interests of the corporation.

To purchase, lease, mortgage, deal in or with all and every class and kind of real estate.

The purposes specified herein shall be construed both as purposes and powers and shall be in no wise limited

or restricted by reference to, or inference from, the terms of any other clause in this or any other article, but the purposes and powers specified in each of the clauses herein shall be regarded as independent purposes and powers, and the enumeration of specific purposes and powers shall not be construed to limit or restrict in any manner the meaning of general terms or of the general powers of the corporation; nor shall the expression of one thing be deemed to exclude another, although it be of like nature not expressed.

To likewise do all and everything necessary, suitable and proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers hereinbefore set forth, either along or in association with other corporations, firms or individuals, and to enter into, make, perform and carry out contracts of every kind and for any lawful purpose, without limit as to amount, with any person, firm, association, corporation, municipality, state or government, or any subdivision or district thereof, and to do every other act or acts, thing or things incidental or appurtenant to or growing out of or connected with the aforesaid objects or purposes or any part or parts thereof, provided the same be not inconsistent with the laws under which this corporation is organized.

### ARTICLE III

The duration of this corporation shall be perpetual.

#### ARTICLE IV

The location and Post Office address of the Registered Office of the corporation in the State of Idaho, is Route #5, Box 20, Rupert, Idaho 83350. The name of the Registered Agent is Ronald Jensen, whose address is Route #5, Box 20, Rupert, Idaho 83350.

#### ARTICLE V

The total authorized number of shares is 2,500. The aggregate par value of the total authorized number of par value shares is TWO HUNDRED FIFTY THOUSAND DOLLARS (\$250,000.00). The stock of the corporation is of but one class: Common. Shares are non-assessable by or on behalf of the corporation.

#### ARTICLE VI
