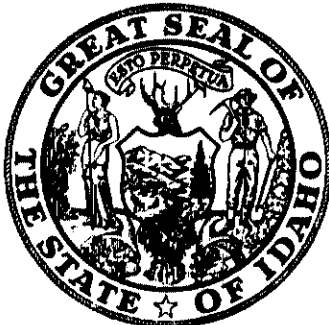

ARTICLE I
NAME

The name of this corporation is Nini Enterprises, Inc.

ARTICLE II
DURATION

This corporation shall have perpetual existence.

ARTICLE III
PURPOSES

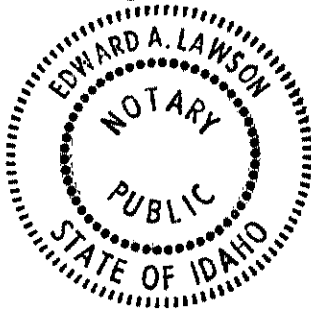
