ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of INDEPENDENT DAIRY SERVICES, INC., a corporation under the Idaho Business Incorporation Act, adopt the following Articles of Incorporation for such corporation:

SECOND: The period of its duration is perpetual.

- (B) To breed, raise, import, export and deal in cattle and livestock of all kinds and to carry on a general cattle and grazing business, purchasing or acquiring, and selling or otherwise disposing of stocks, supplies, equipment, accessories, appurtenances, products and byproducts of such business.

- (C) To carry on any other kind of business or business activities that the Board of Directors may from time to time deem to be advisable or proper in connection with the business.
- (D) To transact any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
