The undersigned, acting as incorporators of **INDEPENDENT DAIRY SERVICES, INC.**, a corporation under the Idaho Business Incorporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is **INDEPENDENT DAIRY SERVICES, INC..**

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

(A) To engage in a general livestock and ranching business both on its own account and as agent; to feed, range, graze, manage, herd, control, brand, care for, purchase, market, and sell livestock of every kind, both on its own account and as agent for other persons or corporations; and to buy, lease, cultivate, manage, operate, and sell ranch properties and products therefrom both on its own account and as agent for other persons or corporations.

(B) To breed, raise, import, export and deal in cattle and livestock of all kinds and to carry on a general cattle and grazing business, purchasing or acquiring, and selling or otherwise disposing of stocks, supplies, equipment, accessories, appurtenances, products and byproducts of such business.

2 Board of Directors may from time to time deem to be advisable or proper in connection
3 with the business.

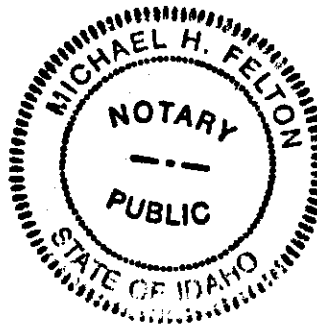
