

## **SCHEDULE 1**

## COMBINED PLAN OF MERGER AND STATEMENT OF SECTION 368(A)(1)(A) REORGANIZATION

This instrument contains the terms of the plan of reorganization as adopted by the sole shareholder and the two directors of the corporations listed on Attachment A collectively referred to as the "terminated corporations" and the sole shareholder of Blaine Larsen Farms, Inc., a shareholder managed corporation. Pursuant to Internal Revenue Regulation § 1.368-3, this instrument also shall constitute the "statement of all facts pertinent to the nonrecognition of gain or loss in connection with the reorganization" to be filed with the surviving corporation's tax return for the year of exchange.

#### 1. Parties

The terminated corporations, are Idaho corporations with principal offices at PO Box 188, Hamer, ID 83425. The federal tax identification number for each of the corporations is stated on Attachment A. The terminated corporations are farming corporations. Blaine Larsen is the sole shareholder and director of the terminated corporations. The terminated corporations' fiscal year end is stated on Attachment A.

Blaine Larsen Farms, Inc., is an Idaho corporation with its principal office at PO Box 188, Hamer, ID 83425. The tax identification number for Blaine Larsen Farms, Inc., is 82-0462034. The fiscal year end for the corporation is October 31. This corporation is a farming corporation. Blaine Larsen is its sole shareholder. The corporation is shareholder managed. The corporation continues the same method of accounting and same fiscal year end as before.

#### 2. Shareholders

Blaine Larsen is the sole shareholder of Blaine Larsen Farms, Inc. and will continue after the merger to be the sole shareholder. The corporation has authorized 1000 shares of no par common stock and prior to the merger has issued 100 shares to Blaine Larsen.

The fair market value of the Blaine Larsen Farms, Inc., stock to be received by Blaine Larsen will have the same fair market value of the terminated corporations' assets and liabilities surrendered in exchange for it. Attachment B lists the values of the terminated corporations' assets and the number of shares of Blaine Larsen Farms, Inc., given in exchange.

Blaine Larsen has no intention to sell or otherwise dispose of the stock to be issued to him. Blaine Larsen Farms, Inc. has no intention to redeem or reacquire the newly issued stock. At the time of their termination, the terminated corporations' will have no outstanding warrants, options, convertible securities, or any type of right under which any person could acquire stock in them.

#### 3. Reorganization

The merger of the terminated corporations into Blaine Larsen Farms, Inc. is a statutory merger under the Idaho Business Corporations Act and, therefore, qualifies as a reorganization within the meaning of section 368(a)(1)(A) of the Internal Revenue Code (Code). Each corporation is a "party to a reorganization" within the meaning of section 368(b). As a result of the merger, the terminated corporations will cease to exist. Blaine Larsen Farms, Inc. will continue carrying on the business and activities previously conducted by the terminated corporations.

The liabilities of the terminated corporations assumed by Blaine Larsen Farms, Inc. in this transaction were incurred in the ordinary course of business. The terminated corporations are not under the jurisdiction of a court in a Title 11 or similar case within the meaning of section 368(a)(3)(A) of the Internal Revenue Code. None of the corporations are an investment company within the meaning of section 368(a)(2)(F) of the Internal Revenue Code.

No gain or loss should be recognized to the terminated corporations on the transfer of its assets to Blaine Larsen Farms, Inc. in exchange for Blaine Larsen Farms, Inc. common stock and the assumption by Blaine Larsen Farms, Inc. of the terminated corporation's liabilities [sections 368(a) and 357(a)].

No gain or loss should be recognized by Blaine Larsen Farms, Inc. upon the receipt of the terminated corporations' assets in exchange for the Blaine Larsen Farms, Inc., stock [section 1032(a)]. The basis of the assets of the terminated corporations immediately before the exchange will be the same basis of the assets in the hands of Blaine Larsen Farms, Inc. immediately after the exchange [section 362(b)]. The holding period of the terminated corporations' assets immediately before the exchange will carry over as the beginning holding period of Blaine Larsen Farms, Inc. immediately after the exchange [section 1223(2)].

No gain or loss should be recognized to the sole shareholder of the terminated corporations' upon receipt of the Blaine Larsen Farms, Inc. stock solely in exchange for the terminated corporations' stock [section 354(a)(1)]. The basis of shares in Blaine Larsen Farms, Inc. will be the same basis as the surrendered shares of the terminated corporations' [section 358(a)(1)]. The holding period of the Blaine Larsen Farms, Inc. stock will include the holding period of the terminated corporations' stock [section 1223(1)].

#### 4. Business purpose, Continuity of proprietary interest

The merger will consolidate the farming operations of all corporations into one entity. This will streamline operations and ease administrative burdens of accounting for numerous corporations. Blaine Larsen continues to be the sole shareholder of Blaine Larsen Farms, Inc.
