Corporate Name

The name of this corporation is FUHRIMAN, BLACK & LEAVITT INSURANCE AGENCY, INDITE

ARTICLE N

Duration

This corporation shall exist perpetually unless sooner dissolved according to law.

ARTICLE III

Principal Place of Business

Any unissued shares of this corporation may be issued, allotted and sold from time-to-time in such amounts and for such consideration as may be lawfully determined by the Board of Directors, subject to the pre-emptive rights of the shareholders. The chares of this corporation shall be non-assessable.
