ARTICLES OF INCORPORATION

OF

MOUNTAIN HOME CHRISTIAN CENTER, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, each being a natural person and a citizen of the United States of America, hereby associate ourselves together for the purpose of forming a non-profit corporation under the provisions of Chapter 10, Title 30, Idaho Code, and do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this Corporation shall be MOUNTAIN HOME CHRISTIAN CENTER, INC.

ARTICLE II

The term of existence of this Corporation shall be perpetual.

ARTICLE III

The registered office of this Corporation shall be located in the City of Mountain Home, County of Elmore, State of Idaho, and the post office address of such registered office shall be P. O. Box 308, Mountain Home, Idaho 83647.

ARTICLE IV

This Corporation shall issue no capital stock but shall issue membership certificates to each member thereof. The rights and interests of all members shall be equal. Such membership certificates shall not be assigned so that the transferee thereof can by such transfer become a member of the Corporation, except by resolution of the board of directors and under such regulations as the By-Laws may prescribe.

ARTICLE V

The board of directors of this Corporation shall consist of such number of persons, not less than three, as shall be prescribed by the By-Laws, and the powers of this Corporation are hereby
