

ARTICLES OF INCORPORATION.

The undersigned, Leonard T. Garrett, Oscar W. Garrett, Clarence A. Garrett, as an individual and as guardian of Wain Garrett, George W. Sample, Philip Joyal, Fred W. Perry, and Hans Albrecht, all bona fide residents of the City of Pocatello, County of Bannock, and State of Idaho, do hereby associate themselves for the purpose of forming a corporation under the provisions and amendments thereof of Title Four (4), Chapter One (1), Idaho Revised Codes:

I.

The name of the corporation shall be: "GARRETT TRANSFER & STORAGE CO., Inc."

II.

The said corporation is formed for the purpose of carrying on a general transfer business and general transfer work, and maintaining and operating taxicabs; engaging in the drayage business; packing and storing goods, wares and merchandise of all kinds, for hire; maintaining and operating a garage or garages; carrying on general repair business of automobiles; buying, selling and leasing real estate, and leasing, renting and operating buildings and warehouses.

III.

The place where the principal business of said corporation is to be transacted shall be in the City of Pocatello, County of Bannock, and State of Idaho.

IV.

The term for which the said corporation is to exist is for fifty (50) years.

V.

The number of directors of the said corporation shall be seven (7), and all shall be elected at the Annual Meeting of the Stockholders. And until the first annual meeting of the stockholders the following shall constitute and be the board of directors:

VI.

The amount of capital stock of said corporation shall be sixty-seven Thousand Dollars (\$65,000.00), and shall be divided into Six Hundred and Fifty (650) shares. The par value of each share shall be One Hundred Dollars (\$100.00).

VII.

The amount of capital stock subscribed, and by whom, is as follows:

Leonard T. Garrett, residing at Pocatello, Idaho One Hundred shares, at One Hundred dollars a share, Ten Thousand dollars.

Oscar W. Garrett, residing at Pocatello, Idaho, One hundred shares, at One Hundred dollars a share, Ten Thousand Dollars.

Clarence A. Garrett, residing at Pocatello, Idaho, One Hundred shares, at One Hundred Dollars a share, Ten Thousand Dollars.

George W. Sample, residing at Pocatello, Idaho, Fifty shares, at One Hundred dollars a share, Five Thousand Dollars.

Hans Albrecht, residing at Pocatello, Idaho, Fifty Shares, at one Hundred dollars a share, Five Thousand Dollars.

Philip Joyal, residing at Pocatello, Idaho, Twenty shares, at One Hundred Dollars a share, Two Thousand Dollars.

Fred W. Perry, residing at Pocatello, Idaho, Ten shares, at One Hundred Dollars a share, One Thousand Dollars.

Clarence A. Garrett, as guardian of Wain Garrett, Ten Shares, at One Hundred Dollars a share, One Thousand Dollars.
