ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, that we the undersigned incorporators being of the age of eighteen years or more, desiring to organize a corporation under the laws of the State of Idaho, do hereby make, sign, and verify these Articles of Incorporation.

ARTICLE I

The name of the corporation is ORGANIZING SOLUTIONS, INC.

ARTICLE II

The period of its duration if perpetual.

ARTICLE III

The purposes for which the corporation is organized are as follows:

- (A) for household and business organization;
- (B) for undertaking all other business activities of any kind or nature for which businesses may be lawfully incorporated under the laws of the State of Idaho;
- (C) to do all other things necessary or incidental to the foregoing business purpose;

ARTICLE IV

The corporation is authorized to issue one class of shares, in a total amount of One Hundred (100) shares. The stock shall bear no par value. Shares of stock of this corporation shall not be transferred or sold until said sale shall be approved by the Board of Directors of this corporation, in accordance with the duly adopted By-Laws of this corporation.

The capital stock of this corporation, after the amount of the subscription price or par value has been paid in, shall not be subject to assessment and no paid up stock and no stock issued as fully paid shall be assessed or be assessable.

ARTICLE V

The address of the initial registered office of the corporation is 6104 S. 83rd St., Boise, Idaho 83725. The name of the initial registered agent at such address is Arthur E. Bohner.

ARTICLE VII

The name and address of the incorporators are the same as in Article VI.

ARTICLE VIII

No private property of the shareholders of the corporation shall be subject to or liable for payment of corporation debts.

ARTICLE IX

By-Laws shall be adopted by the Board of Directors, and when so adopted, may thereafter be repealed, amended or new By-Laws adopted pursuant to law.

ARTICLE X

The Corporation intends to act as what is commonly referred to as a Sub-Chapter S corporation and avail itself of all the rights and benefits accorded to it by law.


ARTICLE XI


