ARTICLES OF INCORPORATION.

KNOW ALL MEN BY THESE PRESENTS, That we the undersigned have this day associated ourselves together for the purpose of incorporating under the laws of the State of Idaho a corporation to be known by the corporate name of The Smith's Fuel Coal, Coking and Mining Company, Limited;

And we hereby certify, that the objects for which this corporation is formed, are: To carry on and conduct the business of mining, coal and other minerals and oil, erecting, constructing, conducting and maintaining cokeing ovens and carrying on the business of cokeing coal, also to purchase coal and mining lands and such other lands as may be necessary in the conduct and management of said business, and selling same as may be necessary to the successful conduct of said business, Said business to be conducted in the States of Idaho, Utah and Wyoming at such points in said states or either of them as may appear to be to the interests of said company.

That its principal office and place of business shall be in the City of Montpelier, County of Iron Idaho and State of Idaho.

That the time of its existence shall be fifty years from and after the date of its incorporation.

That the number of its directors shall be five; and that the names of those who shall be directors and serve as such officers the first year, and until the election of their successors are: E.C. Hanson, Pocatello Idaho, L.A. West, Pocatello Idaho, T.J. Duddleson, Pocatello Idaho, F.B. Richards Montpelier, ^{Idaho} and A.F. Miller, Cokeville Wyoming, That the capital stock of this corporation shall be One Million Dollars, divided into One Million shares of the par value of One Dollar each. That the amount of capital stock subscribed is Six Hundred Thousand Dollars, subscribed by the following named persons to-wit:
