

ARTICLES OF INCORPORATION.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are residents, and bona fide citizens, of the State of Idaho, have this day, and do hereby, voluntarily associate ourselves together for the purpose of forming a Corporation, under the laws of the State of Idaho;

And do hereby certify:

First. That the name of said Corporation is The ^{Idaho} Star Creamery Company Limited.

Second. That the purposes for which this corporation is formed are; to establish a creamery at Star, Ada County, State of Idaho; to build and equip said creamery, or to purchase the same already built and equipped; to own and operate said creamery, and to purchase milk to be used in the same; to carry on the manufacture of butter, cheese, and all other milk products, either for itself direct, or for other persons for hire; to purchase and sell all such milk products; to ^{lease} purchase, own, hold, and use the real and personal property, necessary, or convenient, for the transaction of the business of said corporation, and for the carrying out of its purposes; to lease, mortgage, sell and convey, all the property, real or personal, belonging to this corporation, or any part thereof; to borrow money, and to secure the same by the execution ~~of~~ and delivery of its promissory notes, under its corporate powers and seal, and to secure the payment of said notes, by executing and delivering, by its proper officers, to the holder of said promissory notes, a mortgage on all, or any part, of its property, real or personal, its franchise or corporate rights, said money to be used, in building and equipping, or in purchasing, said creamery, or in enlarging said creamery plant, or in maintaining the same; and in general to do all things necessary.

Third. That the place where the principal business of this corporation is to be transacted is Star, Ada County, Idaho.

Fourth. That the term for which this corporation is to exist is fifty years from and after the Twenty Fourth day of June, A.D. 1899.

Fifth. That the number of Directors for this Corporation shall be seven, who shall hold their offices for a term of one year, and that the names and residences of those who are appointed for the first year of the life of this corporation are:

Sixth. That the amount of the capital stock of this corporation shall be Five Thousand Dollars, divided into one-hundred shares of the par value of Fifty Dollars each.

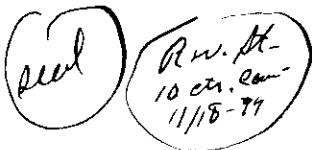
