KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are citizens of the United States, and of the State of Idaho, do hereby associate ourselves together for the purpose of forming a non-profit corporation under and pursuant to the provisions of Title 30, Chapter 3, Idaho Code, and we hereby do submit the following Articles of Incorporation.

Article I

The name of this Corporation shall be: SNAKE RIVER RETRIEVER TRIAL CLUB, INC.

Article II

This Corporation is formed for the purposes and shall have the power:

1. To promote and maintain an organization for the mutual advancement and welfare of its members and of those interested and engaged in the development of and training of Retriever Breeds, and the development and promotion of hunting, by all proper, suitable and lawful means.
2. To foster a spirit of goodwill among its members, and to promote ethical and sportsmanlike practices in their relationship with each other, with those engaged in the training and handling of Retriever Dogs, and in the development and conduct of training of Retriever Dogs, to the end that the general sport of owning, handling and training Retriever Dogs may be improved.
3. To conduct various types and kinds of events wherein breeds of Retriever Dogs are trained and shown in Trials, in accordance with established trial procedure for the handling and holding of such events.
4. To own, lease, exchange, or otherwise acquire and dispose of personal and real property necessary, incidental, auxiliary or convenient to the business of this Corporation and its purpose and objects.


The corporation does have voting members.

Article VIII


