Pursuant to the provisions of the Colorado Corporation Code, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is THE MOUNTAIN STATES TELEPHONE AND TELEGRAPH COMPANY.

SECOND: The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on April 19, 1977, in the manner prescribed by the Colorado Corporation Code:

RESOLVED, That the Articles of Incorporation of the Company be amended by adding a new Article XII to read as follows:

"Shareholders shall have no preemptive right to acquire additional shares of the capital stock of the Company which are issued in connection with the funding of an Employee Stock Ownership Plan benefiting some or all employees of the Company and its wholly-owned subsidiaries, where participation in such a plan is one of

ARTICLES OF AMENDMENT

KULLYSPELL ESTATES WATER ASSOCIATION, INC. 3 4 1/3 OF

The above named corporation submits its first Articles of Amendment as follows:

- 1. The corporation's name is KULLYSPELL ESTATES WATER ASSOCIATION, INC.
- 2. The amendments adopted are adopted to qualify for tax exemption status pursuant to section 501 (c) (12) of the Internal Revenue Code and the amendments adopted are as follows:
 - Funds in excess of those needed to meet current losses and operating expenses shall be retained only to the extent of the organization's reasonable needs for normal business purposes, such as retiring indebtedness, expansion, or maintaining reserves for necessary purposes. Earnings in excess of reasonable needs will be returned to the members in proportion to the amount of business done with the organization.
 - The organization will keep records that show the amount of business done by each member on the basis of its annual accounting period and of each member's rights and interest in the assets of the organization.
 - If a person's membership is withdrawn or terminated, his equitable interest in the organization will not be forfeited.
 - Upon dissolution, if the organization has gains from the sale of an appreciated asset, it must distribute, to the extent practicable, the gains, as well as other funds, to all persons who were members during the period which the asset was owned by the organization in proportion to the amount of business done by such members during that period.
- The amendments were adopted by the shareholders at a meeting on August 23, 1983.
- The corporation has 52 shareholders and 38 voted for the above amendments. No shareholder voted against the amendments.
- The shares are not effected by the amendments, nor is the capital effected thereby.
