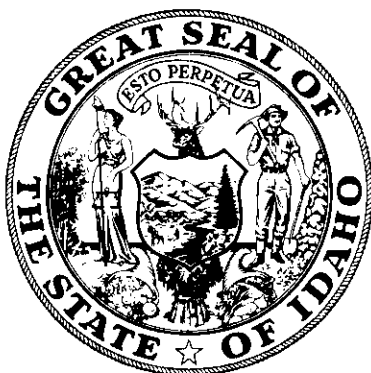

The undersigned, acting as incorporators of a corporation under the Idaho non-profit Corporation Act, adopts the following Articles of Incorporation for such Corporation:

FIRST: The name of the Corporation is VALLEY COUNTY VOLUNTEERS, INC.

SECOND: The period of its duration is perpetual.

THIRD: The Corporation shall be a non-profit corporation. It shall make no distribution of income to its members, directors, or officers.

FOURTH: The purpose or purposes for which the Corporation is organized are: To provide relief for the poor in McCall, Idaho and surrounding areas.

FIFTH: This corporation shall not issue shares but shall issue membership certificates, any adult may become a member and there shall be no limitation upon the number of members. The directors at their discretion may require a reasonable fee for membership.

SIXTH: Provisions denying pre-emptive rights are:

None.

SEVENTH: Provisions for the regulation of the internal affairs of the Corporation are: None.

EIGHTH: The address of the initial registered office of the Corporation is ^{131 PARK STREET} ~~Post Office Box~~ McCall, Idaho 83638; and the name of its initial registered agent at such address is SHAWN M. MILLER.

NINTH: The number of Directors constituting the initial Board of Directors of the Corporation is three (3), and the names and addresses of the persons who are to serve as Directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:

ELEVENTH: The corporation is organized for the relief of the poor within McCall and surrounding areas and toward that end shall have the power to solicit and collect clothing and money for charitable, philanthropic, eleemosynary, and benevolent purposes; to expend, contribute, disburse, and otherwise handle and dispose of the same for such purposes, either directly or by contributions to other agencies, organizations, or institutions organized for the same or similar purpose; and are described in Section 501 () (3) of the Internal Revenue Code and are exempt from taxation under section 501 (a), and to receive by gift, will or otherwise, money or other property, and distribute it as may be deemed best for the promotion of charity and philanthropy and to do any and all other things necessary or proper in connection with or incidental to any of the foregoing.

TWELFTH: No member, officer or director of this corporation shall obtain any salary or profit by reason of their membership or position within this corporation and upon dissolution of this corporation for any reason, none of the assets of the corporation whether money or otherwise shall be distributed to any member, officer or director of

the corporation or to any other individual except to some corporation qualified as a non-profit corporation to receive tax deductible contributions under the laws of the United States and the regulations of the I. R. S.
