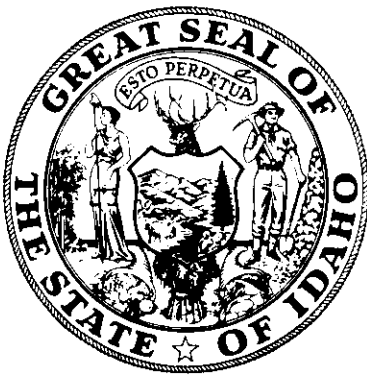

The undersigned incorporator, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE ONE

Name

The name of the corporation is Arties' Catering Service, Inc.

ARTICLE TWO

Purposes

The purposes of the corporation are to carry on business as caterers , bakers and food preparers and dealers in, main dishes and bread products, pastries, cakes, pies, biscuits, and other food products and the various substances and ingredients generally used in all such products; and to construct, purchase, lease, and sell mills, factories, bake houses, shops, buildings, machinery and appliances suitable for such enterprises and to engage in any or all lawful businesses for which corporations may be organized under the Idaho Business Act.

ARTICLE THREE

Duration

The period of duration of the corporation is perpetual.

ARTICLE FOUR

Registered Office and Agent

The address of the corporation's initial registered office in the state of Idaho is 690 Yellowstone Suite G, City of Pocatello, County of Bannock, State of Idaho, 83201. The name of the corporation's initial registered agent at such address is Thomas W. Clark.

ARTICLE FIVE

Stock

The total authorized number of par value shares of stock is Ten Thousand (10,000). The par value shall be One Dollar (\$1.00) , and the aggregate par value of the total authorized number of shares is Ten Thousand Dollars (\$10,000.00).

Directors

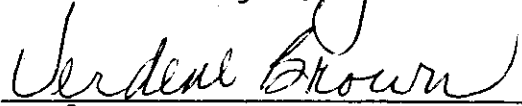
