ARTICLES OF INCORPORATION

OF 4 SP PE W

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for this corporation:

I.

The name of this corporation shall be Total Energy of Idaho, Inc.

II.

The period of existence and duration of the life of this corporation shall be perpetual.

III.

The address of the initial registered office of this corporation is 5219 Chinden Boulevard, Boise, Idaho 83714, and the name of the initial registered agent at such address is David Hyde.

IV.

The nature of the business and the object and purpose of this corporation shall be the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

V.

That the total authorized number of par value shares of this corporation shall be 3000, each of a par value of \$1, and of the
