The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is **LEARNING BLOCK, INC.**

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is organized is to market educational computer software, provide computer training classes and transact any and all lawful business for which corporations may be incorporated within and under the Idaho Business Corporations Act.




