ARTICLES OF INCORPORATION OF LOST RIVERS SENIOR CITIZENS, INC.

That we, the undersigned, do hereby, as incorporators hereof, form a non-profit cooperative association, under the Laws of the State of Idaho, pursuant to, and in compliance with Title 30, Chapter 10, Idaho Code, adopt Articles of Incorporation as follows:

ARTICLE I.

NAME

The name of this Corporation shall be LOST RIVERS SENIOR CITIZENS, INC.

ARTICLE II.

PURPOSES

The purposes of this organization are:

- 1. To promote and effect improved dignity and quality of life for all older residents of the Community.
- 2. To assist the community in benefitting from the resources in knowledge, experience, wisdom, skills, concern, energy and service of older residents of the community. For the purposes of these Articles, the "community" shall include all of Butte County and that portion of Custer County drained by the Big Lost River.
- 3. To receive moneys, equipment or labor from any source, whether private, city, county, state, federal, or whatever, or purchase, convey, mortgage, and lease all kinds of personal

property, or otherwise use funds for the accomplishment of the purposes stated herein.

- 4. To borrow money and to draw, make, accept, endorse, assign, guarantee, execute and issue notes, checks, drafts, bonds, negotiable instruments, and other instruments for the payment of money, and to mortgage or pledge its property to secure such obligation.
- 5. To have, exercise and enjoy all powers now or hereafter granted corporations organized under the Laws of the State of Idaho, and particularly all powers and privileges granted to Corporations under Title 30, Chapter 10, Idaho Code, and in present and future amendments thereto, and to engage in any other activity, and to do any act or other thing necessary to carry into effect the aforementioned purposes.
- 6. To exercise and perform all of the above-described powers, both within and without the State of Idaho.

ARTICLE III.

PRINCIPAL PLACE OF BUSINESS

The location and Post Office address of the Registered

Office of said Corporation shall be the City of Arco, County of

Butte, State of Idaho; Authorized Agent, ALBERT PARSONS, Arco, Idaho.

ARTICLE IV.

DURATION

The duration of this Corporation shall be perpetual.

ARTICLE V.

MEMBERSHIP

This Corporation is organized without capital stock, and membership herein shall be evidenced by Membership Certificates. Rights and interests of all members shall be equal. The qualifications for membership shall be provided in the By-Laws of this Corporation.

ARTICLE VII.

BOARD OF DIRECTORS

The Board of Directors of the Corporation shall consist of no fewer than five (5) nor more than nine (9) members.

ARTICLE VIII. DISSOLUTION

Upon dissolution of this Corporation by operation of law, or otherwise, all assets of the Corporation shall be distributed to a governmental body, or a non-profit corporation, or a corporation with like objectives, and with tax-exempt status under Section 501(c)(3) of the Internal Revenue Code, as is presently enacted.
