

KEEBLER COMPANY (hereinafter called the "Corporation"), a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware, the Certificate of Incorporation of which was filed in the office of the Secretary of State of Delaware and recorded in the office of the Recorder of the County of New Castle, State of Delaware, on May 13, 1965, hereby certifies:

FIRST: That, in accordance with the provisions of
Section 242 of said General Corporation Law, the Board of
Directors of the Corporation duly adopted a resolution setting
forth and declaring the advisability of the amendment of the
Certificate of Incorporation hereinafter set forth; that the
written consent of the holder of all of the issued and outstanding shares of capital stock of the Corporation was given,
in accordance with Section 228 of said General Corporation Law,
to the amendment of the Certificate of Incorporation hereinafter

by the holder of all of the issued and outstanding shares of capital stock of the Corporation amended Article FIRST of the Certificate of Incorporation of the Corporation to read as follows:
