ARTICLES OF INCORPORATION  
OF

JAMES L. JOSTES, D.D.S., P.A.

I, the undersigned, desiring to form a professional Corporation pursuant to the provisions of the Professional Service Corporation Act of the State of Idaho, hereby execute these Articles of Incorporation as follows:

ARTICLE ONE - NAME: The name of this Corporation shall be James L. Jostes, D.D.S., P.A.

ARTICLE TWO - PURPOSES: The purpose for which this Corporation is formed is to render general dentistry and endodontic care and to not engage in any business other than the rendering of professional dental services, provided, however, that it may invest its funds in real estate, mortgages, stock, bonds or any other type of investment and may own real estate and personal property necessary or appropriate for rendering professional medical services and shall have the capacity to act in general to carry on any other lawful business whatsoever in connection with the foregoing or which is calculated directly or indirectly to promote the interest of the Corporation, or to enhance the value of its property, and to have and exercise all rights, powers and privileges which are now or may be hereinafter conferred by the laws of the State of Idaho upon

Corporations, except as in specifically limited by the Professional Service Corporation Act of the State of Idaho, under which this Corporation is formed.

ARTICLE THREE - DURATION: The period of duration of this Corporation shall be perpetual.

ARTICLE FOUR - LOCATION: The location and post office address of the registered office of this Corporation is 999 Main, Suite 1020, Boise, Idaho 83701, in the County of Ada.

ARTICLE FIVE - REGISTERED AGENT: The name of the registered agent of this Corporation, who is located at 999 Main, Suite 1020, P.O. Box 799, Boise, Idaho 83701, is John Eric Sutton, Attorney for Incorporator.

ARTICLE SIX - AUTHORIZED CAPITAL: The amount of the authorized capital with which the Corporation shall commence business shall be One Thousand Dollars (\$1,000.00)

ARTICLE SEVEN - AUTHORIZED STOCK AND CLASSIFICATION: The amount of the total authorized stock of this Corporation shall be one thousand (1,000) shares. Stock of this Corporation shall be of one class, to be known as common stock. Each share of stock of this Corporation shall have a par value of One Dollar (\$1.00).


ARTICLE EIGHT - RESTRICTION: Share of stock of this Corporation may be issued to and owned only by individuals duly licensed to practice the profession of dentistry within the State of Idaho. No share of stock of this Corporation

may be transferred or assigned to any individual who does not hold a license to practice dentistry within the State of Idaho. Existing Shareholders shall have a right to first refusal on all sales of new or previously issued shares of stock of this Corporation. No share of stock of this Corporation may be sold or transferred to a qualified individual without the prior approval of the existing Shareholders. The Corporation will return the shares of stock of this Corporation held by a deceased or disqualified Shareholder, provided that such redemption does not result in the impairment of the Corporation's capital.
