ARTICLES OF AMENDMENT

OF

On this day a meeting was held for the purpose of amending Article V of the present Articles of Incorporation and there were present the following:

Stanley B. McDonald Thomas J. Bannan

This represented all of the outstanding stock of the corporation. Each of the stockholders orally waived notice, consented to the holding of the meeting, and the following resolution was adopted.

BE IT RESOLVED, that Article V of the Articles of Incorporation, presently reading as follows:
"The total authorized capital stock of this corporation shall be Forty Thousand Dollars (\$40,000.00). There shall be four hundred (400) shares of the par value of One Hundred Dollars (\$100.00) each."
be amended to read as follows:

Total authorized capital stock of this corporation shall be fifty-five thousand dollars (\$55,000.00) represented by five hundred fifty (550) shares of the par value of one hundred dollars (\$100.00) each.

The previously authorized capital stock of Air-Mac,

Inc. of Washington was forty thousand dollars (\$40,000.00) evidenced by four hundred (400) shares common stock of the par value of one hundred dollars (\$100.00) each.

The presently authorized capital stock of the corporation is fifty-five thousand dollars (\$55,000.00), evidenced by five hundred fifty (550) shares common stock of the par value of one hundred dollars (\$100.00) each.

There is only one class of stock, that class being common stock of the par value of one hundred dollars (\$100.00) per share, which stock represents the voting power of the shareholders of the corporation. The amendment was adopted by unanimous vote of all shareholders.
